

DIRECTIONS TO BROOKLAKE COUNTRY CLUB

139 Brooklake Rd Florham Park, NJ 07932 (973) 377-2235 Fax (973) 377-9091

From Garden State Parkway South

Exit 142 to Route 78 West (see directions from 78 East or West)

From NJ Turnpike North or South

Take Newark Airport Exit 14 to Route 78 West. Stay in local lanes. (see directions from 78 East or West)

From Route 287 North or South

Take Exit 37, Route 24 East continue to Florham Park Exit 2-B. Follow Columbia Turnpike for Approximately two miles. Make right turn onto Ridgedale Avenue. Go one traffic light, make left turn onto Brooklake Road. Follow for two miles. Brooklake Country Club is on the right.

From Route 78 East or West

Take Route 24 West. Continue on Route 24 to Exit 7 B-A taking the Chatham – Route 124 Ramp. Follow Route 124 (Main Street) to 6th traffic light. Make right onto Brooklake Road. Continue approximately 1 mile thru blinker, ½ mile past blinker. Entrance on left.

From Route 80 East or West

Take Route 287 South to Exit37, Route 24 East continue to the Florham Park Exit 2-B. Follow Columbia Turnpike for Approximately two miles. Make right turn onto Ridgedale
